# Narrative Description of Indicator

The MSDE has developed and submitted a Request for Proposal for a vendor who can collect, aggregate, and analyze valid reliable data that measures parent involvement of students with disabilities in Part B of IDEA (ages 3 through 21) who repose schools facilitated parent involvement as a means of improving services and results for students with disabilities. In accordant the advice of OSEP, MSDE is now using a census based approach to gather data from all twenty-four local school systemanually. The surveys were distributed to parents by school based providers and returned to the vendor in a postage paid envelope. MSDE utilized members of the Maryland SESAC, local SECACs, and our Partners for Success/Family Support Netw Centers to encourage parents to respond to the survey. The completed surveys were scanned and analyzed by an independence and the results are reported below. The vendor utilized Rasch measurement techniques and related data analysis r to accurately assess the data collected through the survey.

# View School Age Results -

Overall 2,913 of 8,105 (37%) of parents of school-aged children reported that schools facilitated parent involvement as a n improving services and results for children with disabilities. This is twenty (20) percentage points lower than reported in F (57%). Responses range from 38% to 36%. As noted with the preschool population, one local school system is underrepreser the respondents. When comparing current data with data from the previous school year, parents in this local school system more negative about their involvement in their child's special education program. Thus, the numbers reported this year in more positive involvement in their child's special education program. The distributions by grade, age of child, and age whereferred for services are fairly comparable with that observed in the previous school year. These data have less Blacks and

Americans responding, which is also related to the low survey response in one local school system. Basically, all of the res live in Maryland (0.3% are from outside the State). Distributions for the other demographics, reveal:

- Slightly less than half of the children are 10 and under (43%).
- Dividing the ages of the children in three year increments yields almost the same percentage in each group, varyin 18 percent to 25 percent.
- The majority (62%) of the children were identified for early Intervention or special education before age 6.
- More than half of the children are White (54%) with another 29% being Black or African American.

### View Preschool Results -

Overall 700 of 1,658 (43%) of parents of preschool-aged children reported that schools facilitated parent involvement as a of improving services and results for children with disabilities. This is a twenty-six percentage point decrease over FFY 200 Responses ranged from 46% to 41%. The overall percentage is also probably slightly higher than the "true" value because or school system's respondents are underrepresented. In FFY 2006, respondents from this local school system scored lower or Indicator, and this was statistically significant. Almost all of the respondents lived in Maryland (99.7%). The number of respondents enough data for reliable statewide estimates. Distributions for the other demographics reveal the following:

- Sixty-one percent of the respondents were parents of preschoolers, 4 or 5 yrs. of age
- Just over half the respondent's children (55%) were referred for services before the age of 3
- Over half (56%) of the respondents were white, about one-fifth (21%) were Black or African American, 9% Hispanic identified themselves as multiracial
- The three most frequently cited disabilities (speech or language impairment, developmental delay, and multiple disabilities) account for 82 percent of the disabilities cited
